Board of Directors' goal to ensure compliance and enforcement of COVID-19 mandates, as outline by local and state government officials, as well as to ensure a safe environment at the Association's pool facilities.

IN CONSIDERATION of INDIAN CREEK HOMEOWNERS ASSOCIATION, INC. allowed me use of the pool facility; I, for myself, and only behalf of my spouse, children, parents, guardians, heirs, and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Release and Waiver of Liability.

I acknowledge that I am solely responsible for any medical or other costs arising out of any bodily injury, sickness, or property damage sustained by me or any person who resides at my property while using the pool facility. I certify that I have adequate insurance coverage, including health and accident, for any injuries or illness that I may sustain as a result of using the pool facility.

I full certify that INDIAN CREEK HOMEOWNERS ASSOCIATION, INC. shall not be liable to me, my children, or any person who resides at my property on account of any personal injuries or sickness sustained by them as a result of using the pool facility. I hereby release, indemnify, and hold harmless INDIAN CREEK HOMEOWNERS ASSOCIATION, INC. from all liability for all personal injuries, sickness, or property damage related to the Association's decision to open the pool facilities, allow me or any person who resides at my property access to such facilities, or person I encounter at the pool facilities.

I further covenant and agree that I will not sue INDIAN CREEK HOMEOWNERS ASSOCIATION, INC., that Board of Directors of OCHOA, its members individually, its officers, agents, or employees for any claim for damages, for bodily injury or other, arising from my use of the pool facility in INDIAN CREEK HOMEOWNERS ASSOCIATION, INC. including, without limitation, the current board of directors of INDIAN CREEK HOMEOWNERS ASSOCIATION, INC. and any management company that it so employs, including, without limitation, Goodwin & Company, or Robert's Pool Services. I agree that I will pay any and all attorney's fees and costs of court in any suit files between me and INDIAN CREEK HOMEOWNERS ASSOCIATION, INC., the Board of Directors of INDIAN CREEK HOMEOWNERS ASSOCIATION, INC., Goodwin & Company, and/or Robert's Pool Services. In an effort to decrease the risk of injury or sickness at the pool facilities, I and all persons who reside at my residence agree that we will abide by the following Rules established by the Association:

- 1. I will maintain safe social distance of a minimum of six feet apart for anyone not residing in the same household
- 2. I will not use the pool if I or a member of my immediate household have a fever, headache, or any other illness, including but not limited to, COVID-19
- 3. I will wash my hands often and attempt to avoid close contact with those of other households
- 4. I will cover my coughs and sneezes and wear a face mask whenever possible
- 5. I agree to clean and disinfect any surface I frequently touched at the pool facility, before and after use
- 6. I will limit occupancy of the pool facility to no more than the state mandated occupancy limits

7. I understand that the enjoyment of the pool is for residents only. I will not invite or bring any guests of those that reside in my household due to limited occupancy

I understand that this release, and waiver of liability, and covenant not to sue shall remain in effect in perpetuity. I understand that my pool card will not be activated unless this waiver is signed.

All covenants contained herein are severable, and in the event of any being held invalid by any competent court, this agreement shall remain intact except for the omission of the invalid covenant. It is the intention of both parties that all suits that may be brought arising out of, or in connection with this Release and Waiver will be construed in accordance with an under and pursuant to the laws of the State of Texas and shall be litigated in Denton County, Texas.
